# CONDITIONS OF ENTRY WHEREIS AND DICK SMITH GROUP FUEL CARD PROMOTION

## Terms and Conditions

3. The Promoter is Sensis (ABN 30 007 423 912) of 222 Lonsdale Street, Melbourne Victoria 3000 ("**Promoter**"). For any queries regarding this promotion, please call 1300 663 767.
4. The Offer is open from 12:01am (AEST) on 25 May 2008 to 5:00pm (AEST) on 30 June 2008 ("**Offer Period**"). All Offer claims must be received by the Promoter by last mail on 15 July 2008 to be eligible.
5. Participation in the Offer is open only to Eligible Participants.
